It is hereby STIPULATED and AGREED, by and between all parties in this lawsuit, as follows:

2. The Scranton Times, L.P. employed Chris Kelly and Larry Holeva on February 14, 2021.

6. The parties agree that all admissions and denials of Times Shamrock Communications and The Scranton Times-Tribune set forth in their Answer and New Matter shall be considered the admissions and denials of The Scranton Times, L.P.


7. Plaintiff, Philip Godlewski, now seeks to dismiss any and all claims he has for economic damages or special damages against all defendants in this lawsuit.


